INFORMATION:

I was dispatched to the Livingston County Sheriff's Office to make contact with Holly Austin. Holly advised that she was being harassed by someone.

I made contact with Holly and her husband, Shawn Austin. I spoke with them inside a room at the Sheriff's Office.

STATEMENT OF HOLLY AUSTIN:

On December 7th Holly advised that she spoke at a Brighton Area Schools special meeting regarding mask mandates for students.

Holly is a parent with children in Hartland Schools and is concerned that Hartland Schools will impose mask mandates if Brighton Schools implement one. Holly is a professor of Nursing at Schoolcraft college.

On December 10th she received a text message that she was being "attacked" on Social Media by Kasey Helton. Holly has never had any contact with Kasey.

Holly started to review posts from Kasey. The posts called for her to be fired from her job. Kasey labeled her "Holly Austin, a Dangerous RN" in many social media posts. Kasey posted that Holly lives in Howell and where she works. Kasey posted a "blown up" picture of Holly with the caption "is she yours" and sent it to her employers social media. She uses the hashtag #firehollyaustin and "Holly Austin, Dangerous RN" on unrelated posts from her employers social media pages.

Kasey has called for the accreditation of her employer's nursing program to be revoked by accrediting bodies of nursing. Kasey has tagged and identified Holly to organizations in charge of licensing and accrediting nurses. Kasey has tagged many "left leaning" organizations to encourage further attacks on Holly.

Holly advised that she is afraid for her life and her family's lives. Holly is scared that Kasey will use violence in an attempt to "silence" her. Kasey recently indicated that she has guns via her social media platforms.

Holly forwarded me 73 pages of social media posts starting from after the meeting.

Holly advised that she has lost weight, is stressed and in constant distress. She is constantly checking her surroundings because she is scared she or her family will be attacked.

Kasey is also targeting another woman who is a nurse that spoke at the meeting.

Holly advised that she was applying for a PPO against Kasey.

DEPUTY'S ACTIONS / OBSERVATIONS:

I gave Holly the complaint number and they cleared the office.

I uploaded Hollys PPO request and copies of Kasey's social media posts.

CONTACT WITH KASEY HELTON:

I made contact with Kasey via telephone on 12-13-21 at approximately 1230 Hrs.

I asked Kasey if she was making posts on social media in reference to Holly Austin. Kasey advised that she was and that she was doing nothing illegal.

I advised her that there was a complaint made and that I would be sending the report to the Livingston County Prosecutors office for review. Kasey asked her what crime she was being charged under. I advised her I was requesting charges for "Posting message through electronic medium". I provided Kasey with MCL #750.411s.

Kasey wanted to argue about the charges, I advised her that the prosecutors office is the one who makes he charging decision.

Kasey attempted to talk about complaints she made with the State Police. I advised her I could not comment on prior incidents that I was not involved.

STATUS:

Closed, a copy of this report will be forwarded to the Livingston County Prosecutors Office for review.
